JOHN J. KILLIAN SCHOLARSHIP

The John J. Killian Scholarship Award is awarded to a full-time student enrolled as an accounting major in their junior year at an independent Kansas college or university. Each independent Kansas college or university is limited to one John J. Killian Scholarship nominee per academic year. The Scholarship is awarded to one selected nominee.

Qualified nominees must demonstrate academic success in the accounting curriculum. Additional emphasis is placed upon the nominee's grades in English and rhetoric subjects as well as courses in business and economics. Important qualifications also include the nominee's involvement in leadership activities, willingness to comply with standards of professional responsibility, and overall moral character. Demonstrated financial need is not a necessary element of the John J. Killian Scholarship Award.
